The Boys & Girls Club of Fitchburg and Leominster's operation budget is in excess of \$700,000 a year. The majority of our revenues come from gifts of individuals, corporations, and foundations. We also receive a small amount of government support. This government grant, \$13,000, is a federal Fitchburg Community Development Block Grant, CDBG, administered by the U.S. Department of Housing and Urban Development, HUD. HUD has requested we collect the information below and provide it to them. The information will be kept confidential and will be used only to meet the record keeping requirements of the federal grant. It is also helpful in appealing to donors and granting agencies. Be assured however, we will not release specific financial information about you, your child or your family to any other donor or agency without first gaining your permission. By completing the requested information, you are giving permission only to allow us to maintain it and allow HUD authorized auditors to review it.

Your obligation to the club and its supporters

It is critical that families participate with our donors in supporting their kids at the club. We ask all families to contribute their fair share of \$30 per month, \$300 a year per member. It is set low so that it is affordable by all but it is significant enough to makes you a partner with staff, volunteers and donors at the club.
